What is the Delivery Body Portal?

- The Delivery Body Portal is where you will register your company, create and submit your CfD application, and submit seal bids.
- All Information and supporting material for the CfD Registration process and submitting a CfD application for Allocation Round 4 will be available via the Delivery Body Portal.

When is the CfD Registration Window?

- Registration Window: 4 October 2021 14 January 2022
- Application Window: 13 December 2021 14 January 2022
- Although the Registration Window closes on the 14 January 2022, we cannot guarantee that we will be able to process company registrations submitted after 7 January 2022.
- The Delivery Body SLA to process Registrations will be 5 working days.

What's New for AR4 Registration?

Automatic Registration Process

 As always, any anonymous user without creating an account on the portal can register a Company on the portal for both Capacity Market and Contracts for Difference. The new addition is a question that is asked to the user to ascertain whether the company They are trying to register on the portal is already registered in Companies House UK or not. Question – "Is this company registered at Companies House UK?". It is a mandatory Question that the user needs to answer by Selecting "Yes" or "No (If No, you will be required to fill in the form manually which is detailed in the CfD Company Registration and User Management Guidance document)"

Digital signing of Registration form & OTP

 As part of this change one functionality that has been using which the Authorised Person can sign the registration form (link provided via an email) by providing their Full Name after verifying themselves using a six-digit One Time Password (OTP) sent to the Mobile Number provided in Authorised Person Section of the Company Registration Form. This process is further explained in the CfD Company Registration and User Management Guidance document.

Common Errors on Application Form

- All mandatory fields have not been filled in before the 'submit' button
- Declarations are not completed
- Uploaded documents are not signed and dated
- Uploaded documents do not have the correct CfD Unit details
- For phased delivery, the dates entered are not sequential
